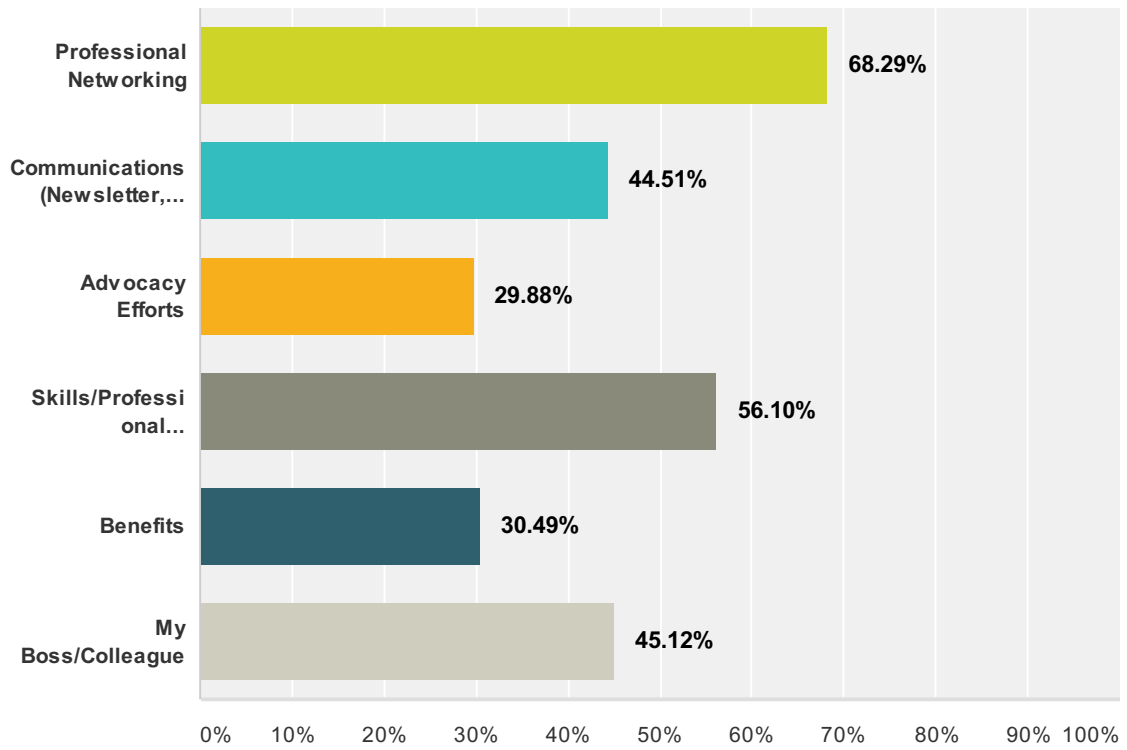

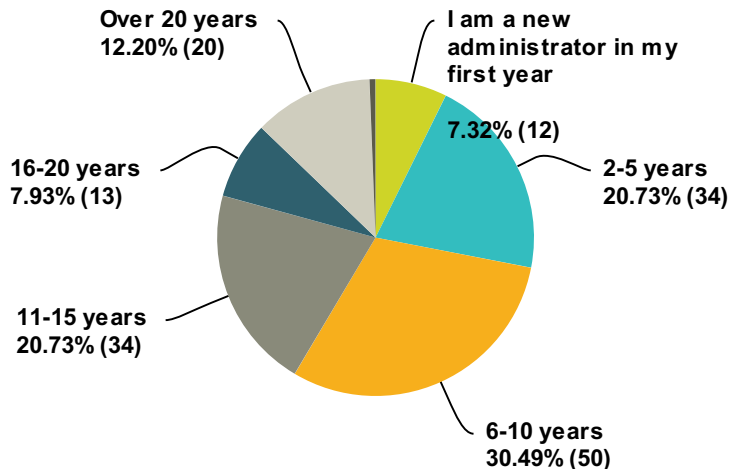
## Q2 What Motivated You to Join ACCCA?

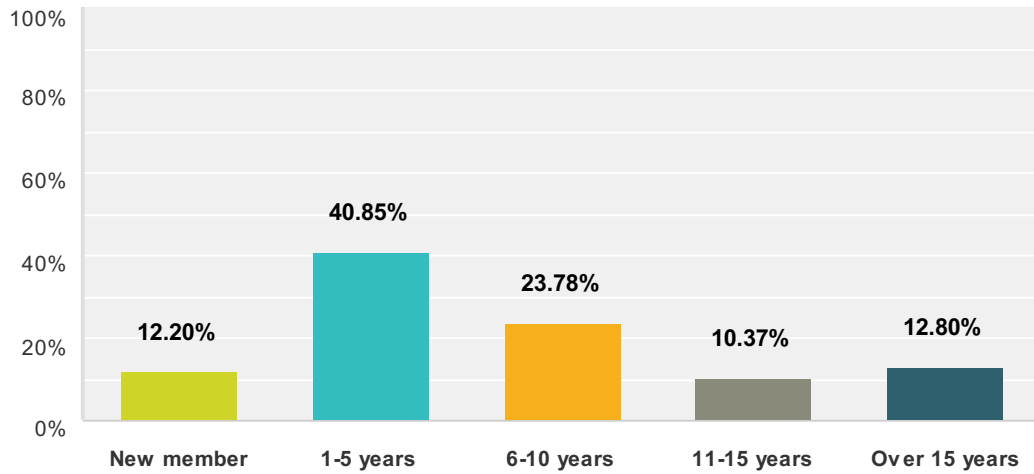

### Q4 How long have you been an ACCCA member?

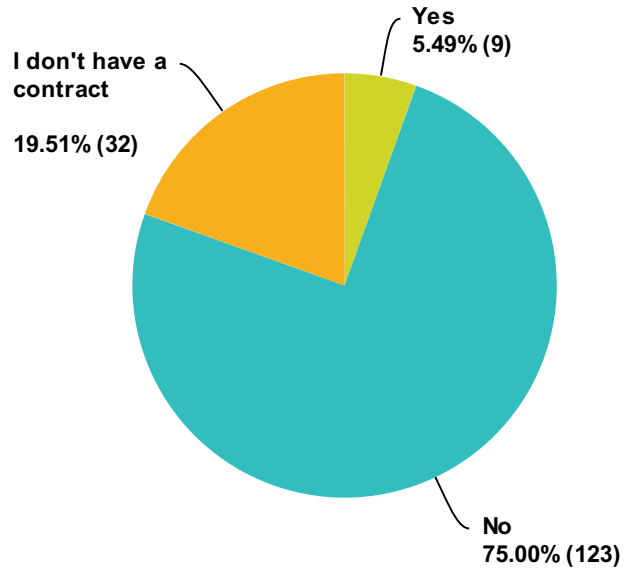

### Q5 Is your ACCCA Membership cost included in your current contract

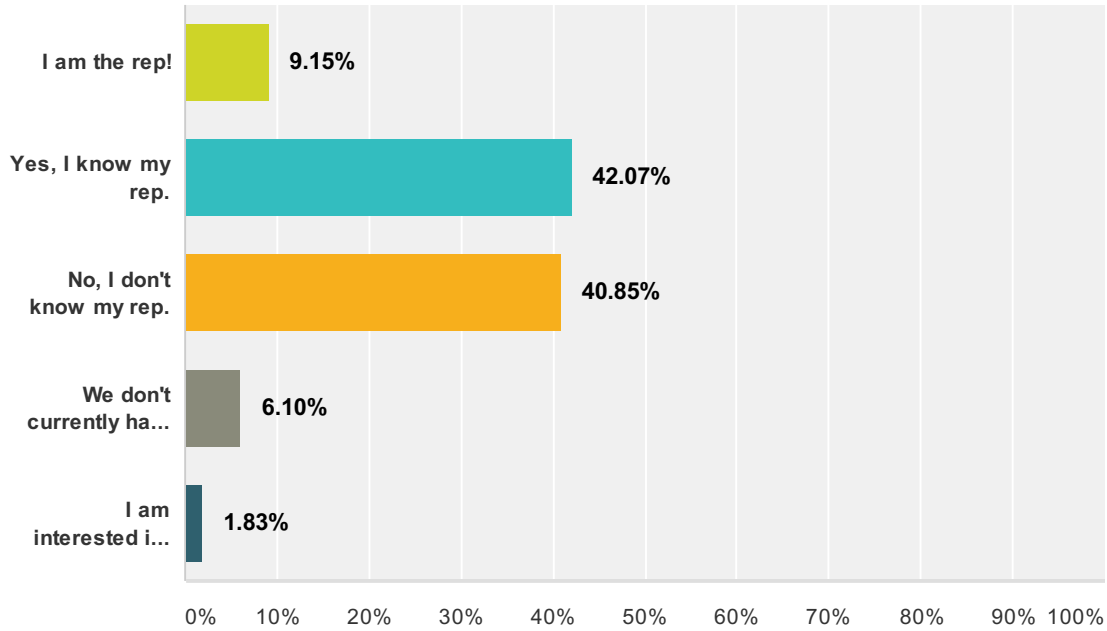

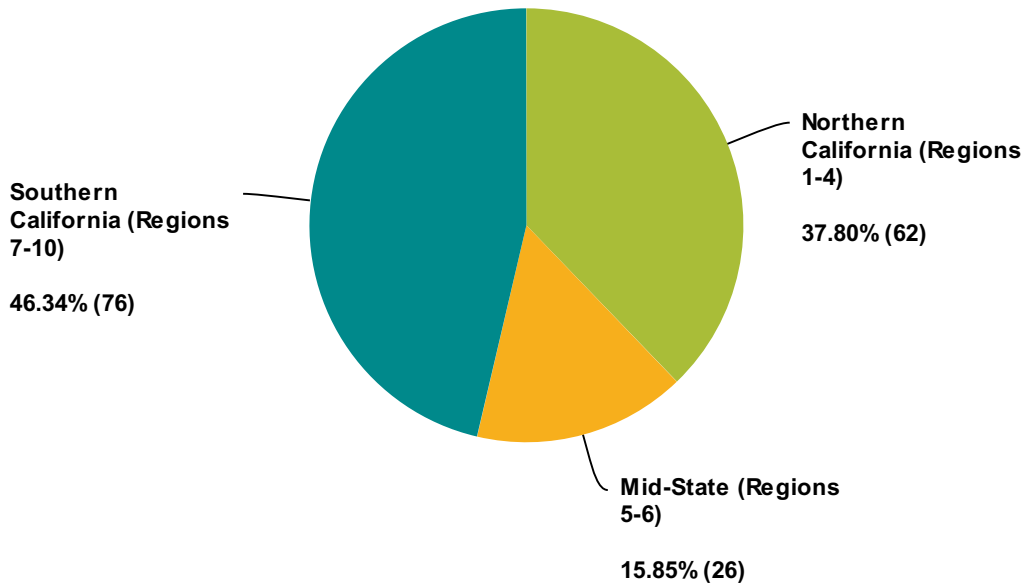

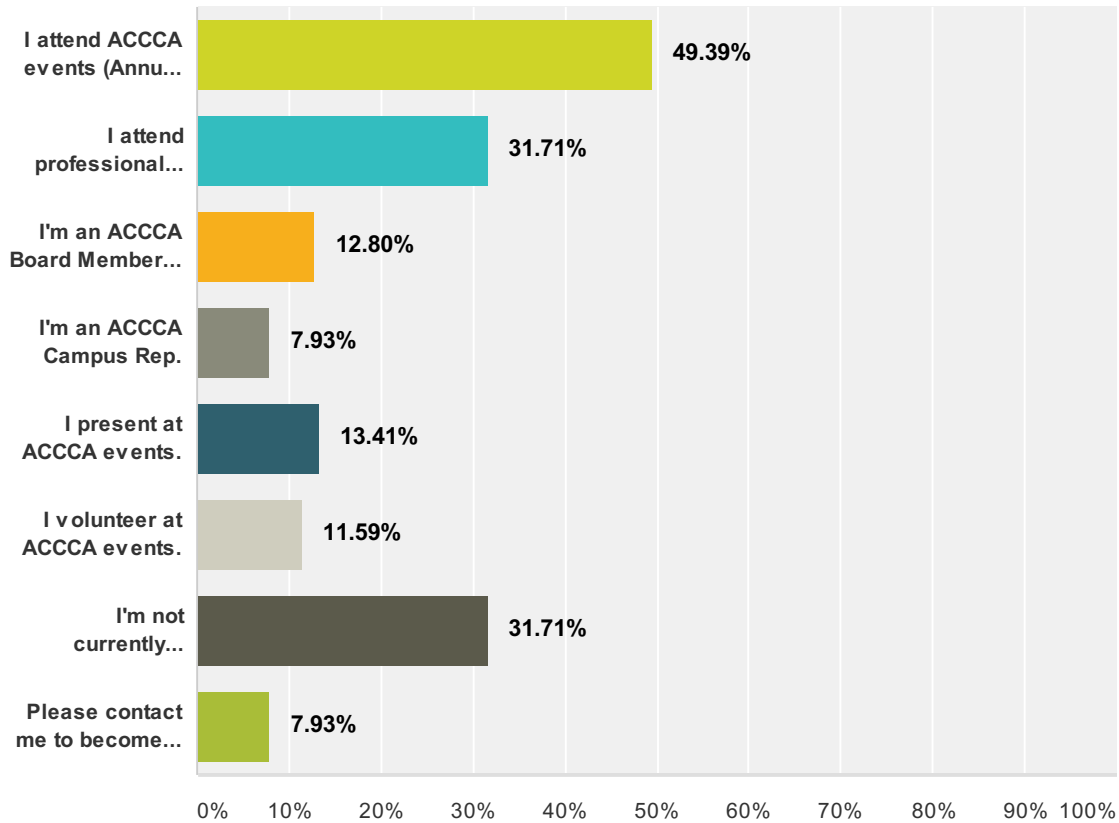

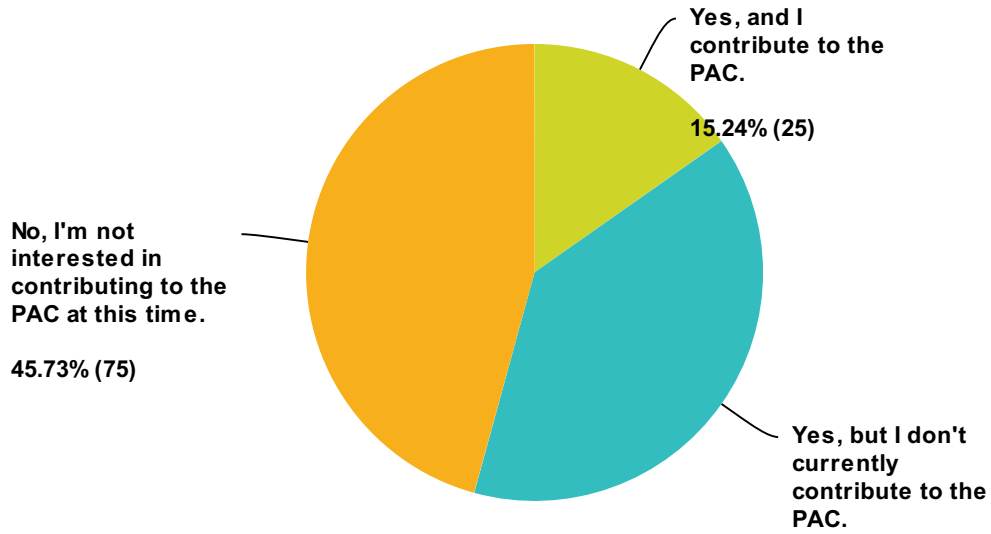

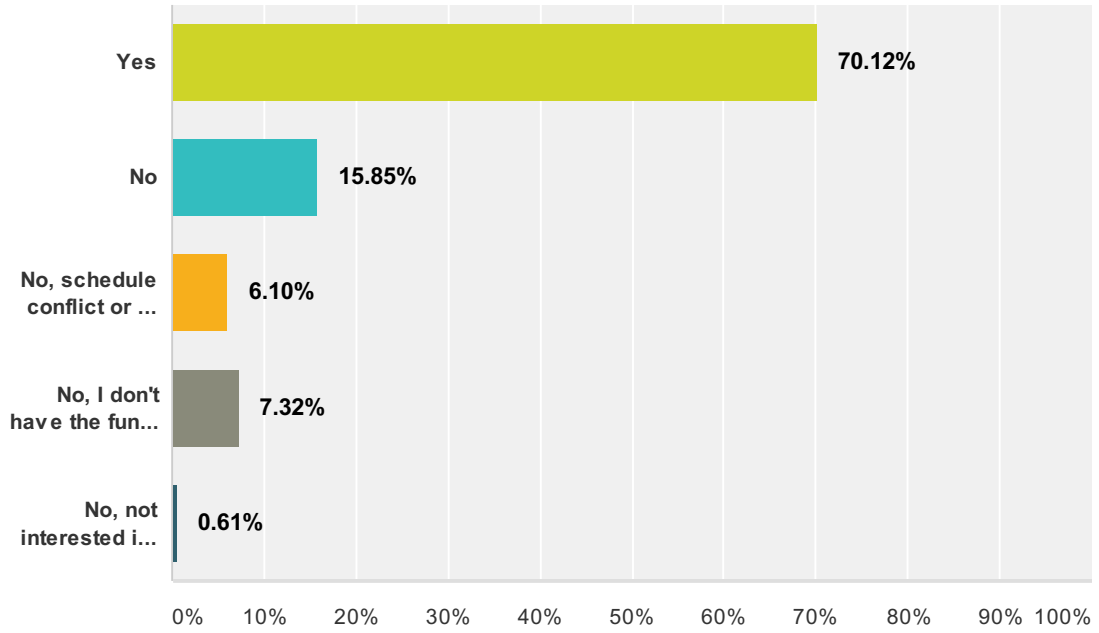

### Q19 Have you ever attended an ACCCA Conference?

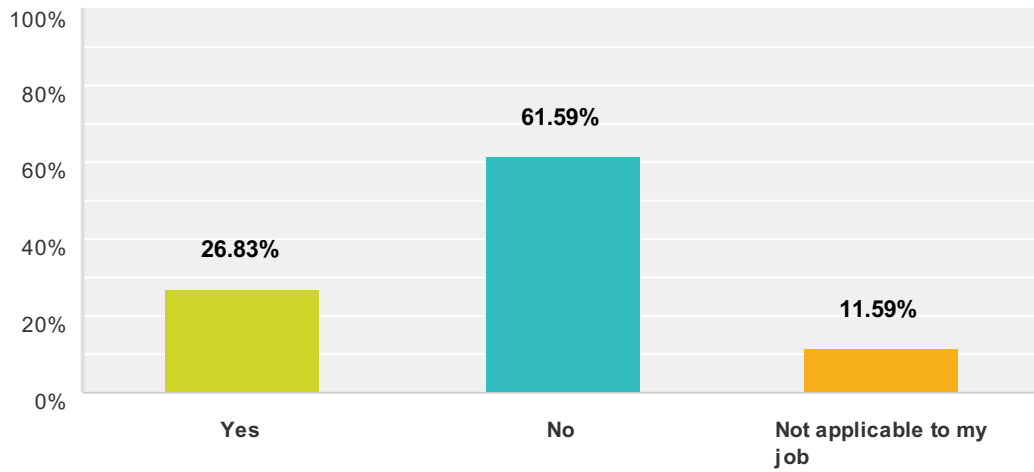

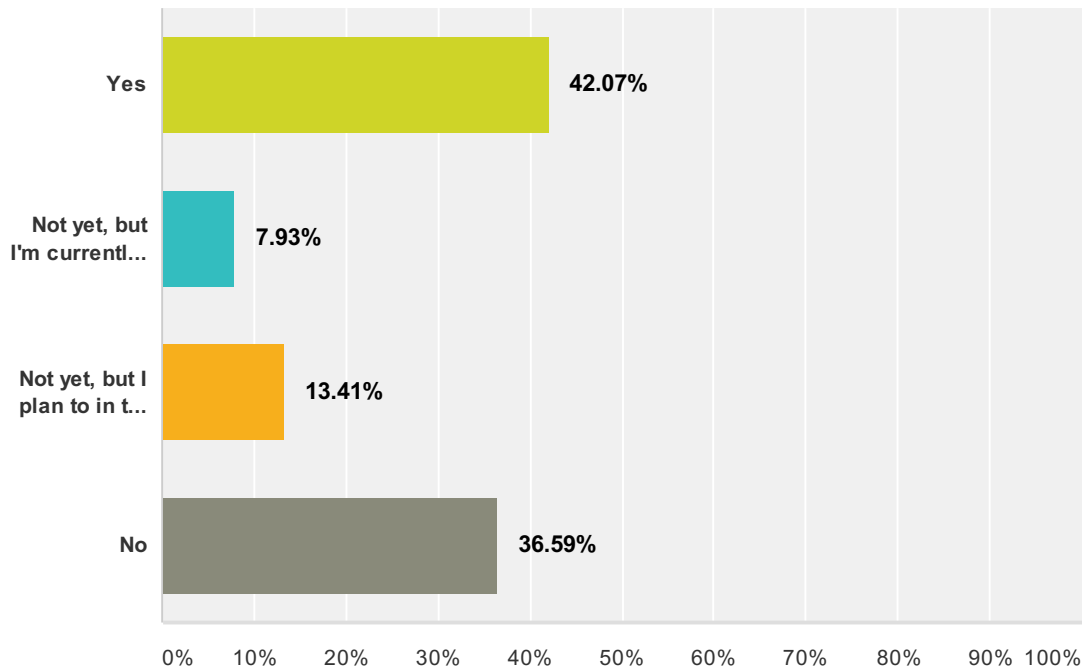

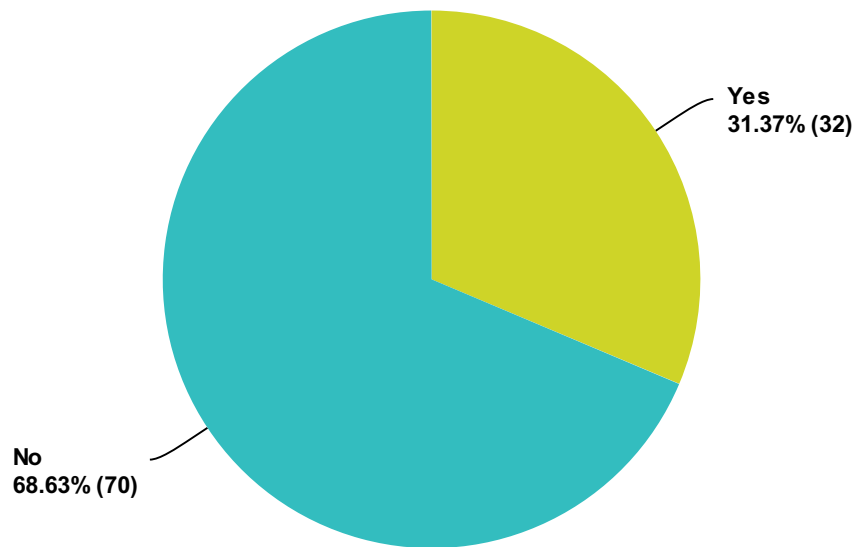

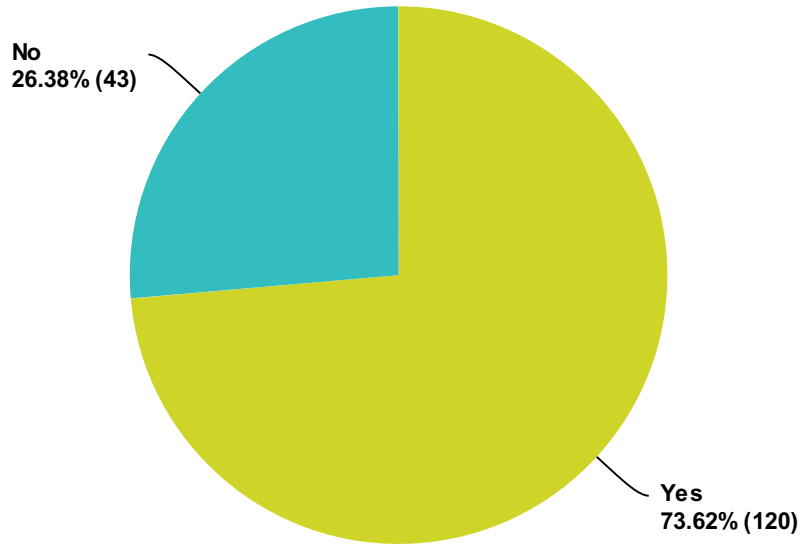

**Q23 Do you visit the ACCCA website?**

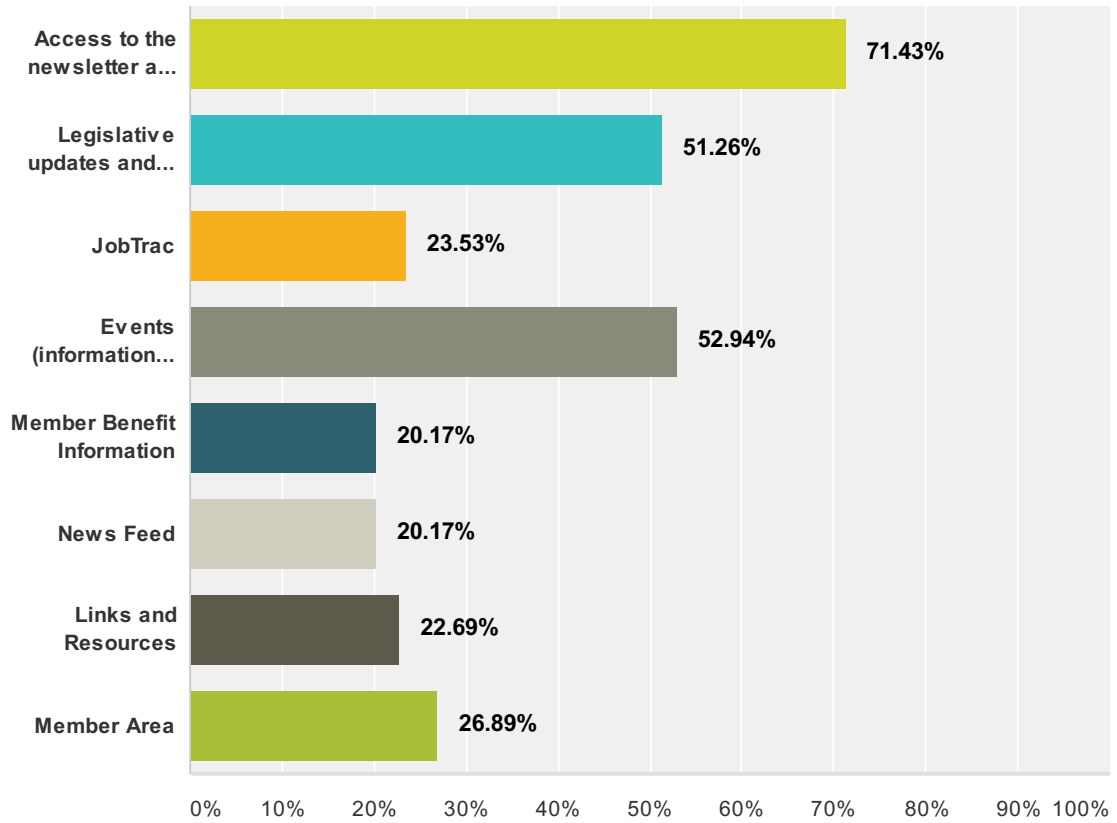

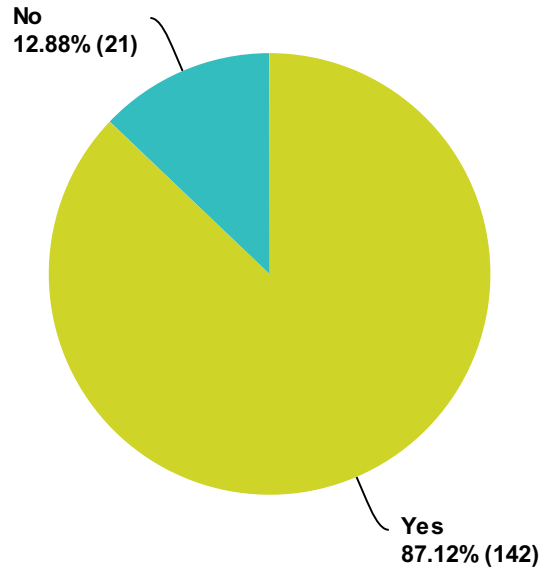

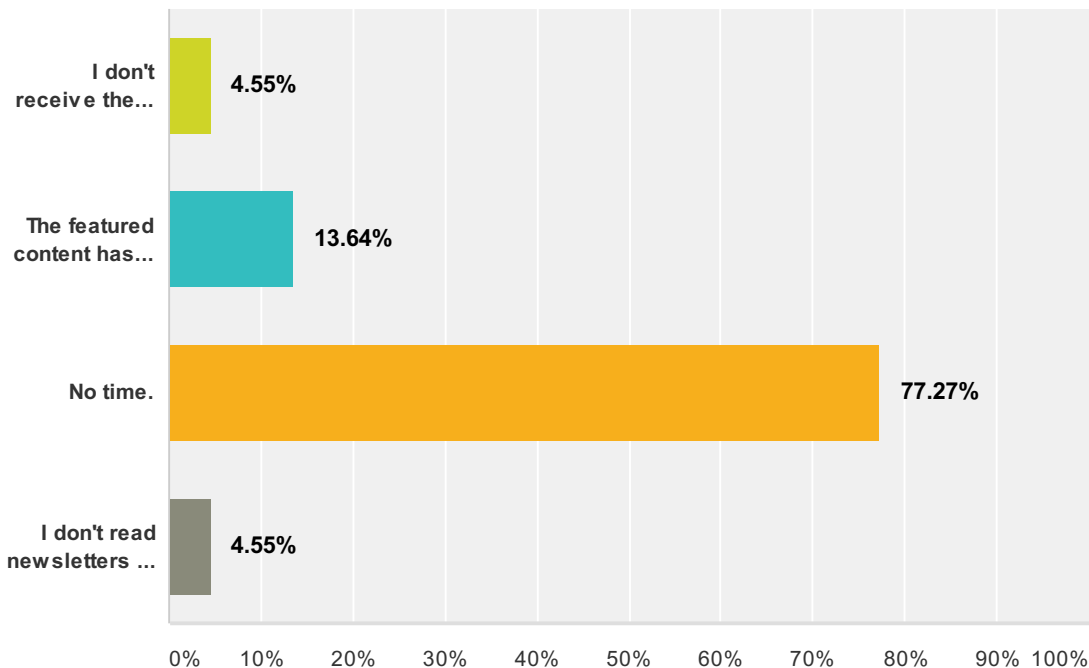

### Q26 If you don't read ACCCA Reports, why?

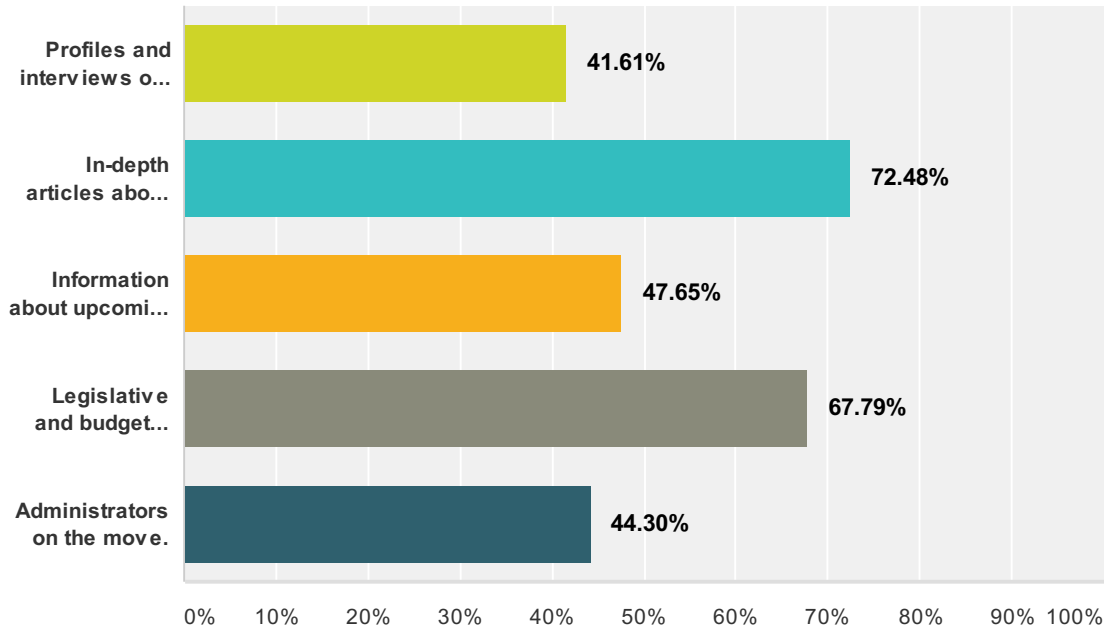

**Q27 Assuming you do read the newsletter, what kinds of articles do you turn to first? (Check all that apply.)**

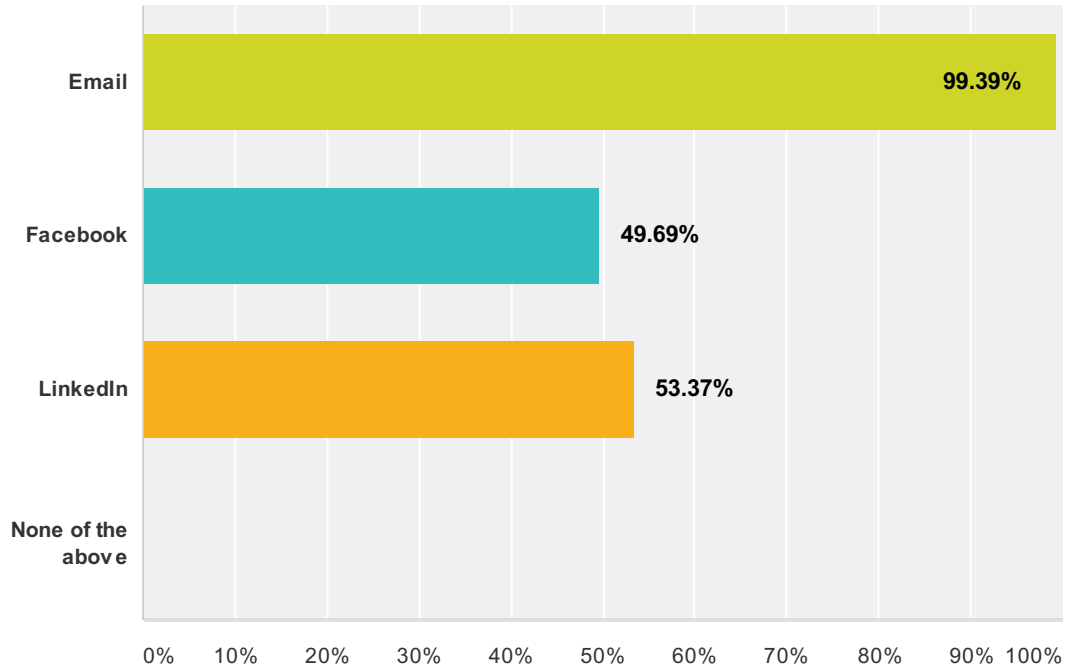

**Q28 Which of the following communication tools do you currently use, either professionally or personally? (Check all that apply.)**

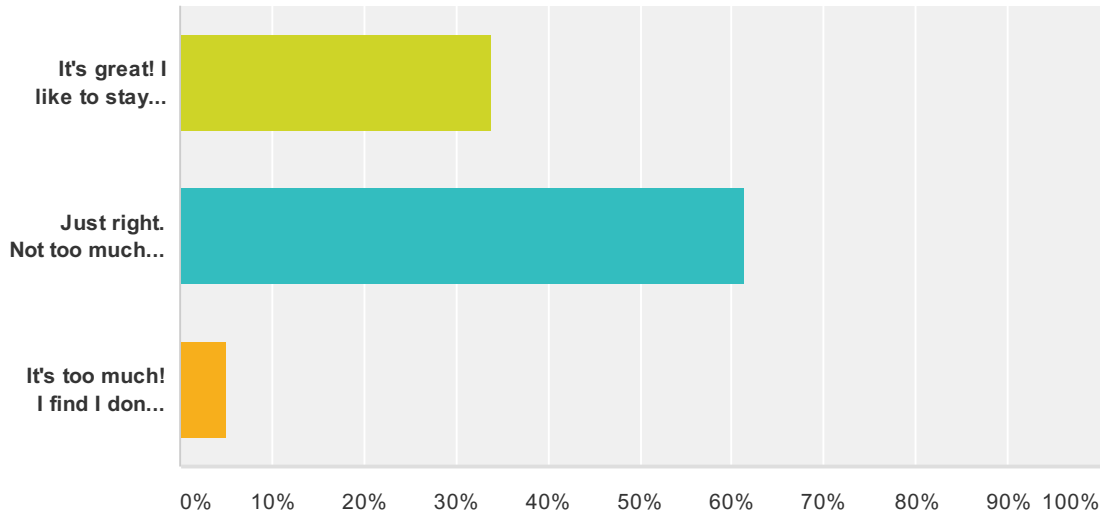

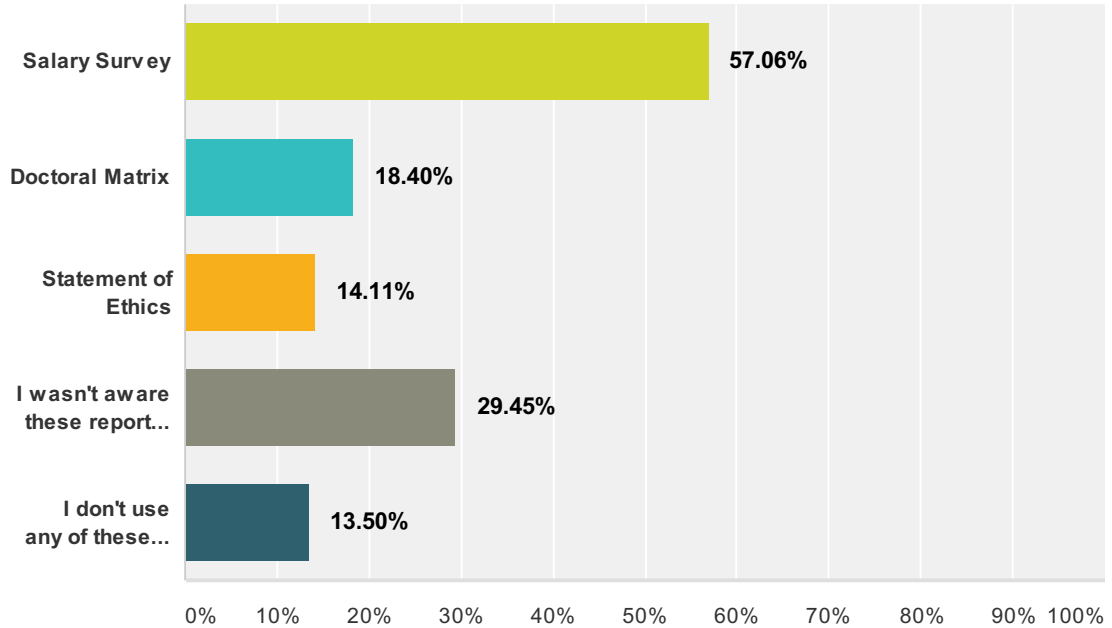
